备注 Note:

- 1、若客户在 CHTC 获得认证, 或同时申请中国有机和 CHTC-EU 有机认证时, 根据企业实际情况重新核算认证费用, 可给予一定折扣。If the operator has already been certified through CHTC whether in organic or other certification scheme, or the operator applies for China organic and CHTC-EU organic at the same time, the certification fee will be calculated with certain discount at applicable.
- 2、若申请认证产品数量较多, 或加工流程较复杂, 认证费用会适当增加。When the products number is large, or the processing activity is complex, the certification fee might increase at applicable.
- 3、若客户在现场检查前提出不继续认证, 可退 50% 的认证费用。若客户在现场检查后提出不继续认证的申请, 则认证费用不退。If the application is withdrawn before an inspector has been assigned, one half of certification fee may be credited. If withdrawn after inspection has been taken, certification fees are nonrefundable.
- 4、CHTC-EU 有机认证执行标准为 Regulation (EU) 2018/848 及相关二级法律法规。The CHTC-EU organic certification standard is Regulation (EU) 2018/848 and related secondary legal acts.

补充说明 Addendum:

对于备注中第一条提到的情况, 若企业已在 CHTC 获得其他认证, 或同时申请多个认证, 认证费用可给予一定折扣。市场部人员可根据企业情况和该项目市场竞争情况决定折扣力度, 但最低不得低于以下折扣, 且不得累加 For the circumstance mentioned in the above note point 1, if the operator has already been

certified by CHTC or is applying multiple scopes, the certification fee can be charged with discount. The marketing staff can decide the discount according to the actual situation of the operator and the market competition. But the maximum discount shall not exceed the following provision, the following discount shall not be accumulated.

1、若已获得中国有机产品认证，CHTC-EU 有机认证费用最低可打 7.5 折；若连续三年以上在 CHTC 获得中国有机产品认证，CHTC-EU 有机认证费用最低可打 6 折。When the operator has already been certified for China organic by CHTC, the certification fee for CHTC-EU organic can have a maximum 25% discount; When the operator has been certified for China organic by CHTC for over 3 years, the CHTC-EU organic certification fee can have a maximum 40% discount.

2、对于新申请认证的企业，若同时申请中国有机和 CHTC-EU 有机认证时，CHTC-EU 有机认证费用最低可打 7.5 折。When the operator applies multiple scopes including China organic and CHTC-EU organic together for the initial certification, the CHTC-EU organic certification fee can have a maximum 25% discount.

3、若企业已在 CHTC 获得其他认证（例如：质量管理体系、食品安全管理体系、HACCP 等），CHTC-EU 有机认证费用最低可打 8 折。When the operator has already been certified by CHTC for other scopes, such as ISO 9001, ISO 22000 or HACCP), the CHTC-EU organic certification fee can have a maximum 20% discount.
